## **Please read the below excerpts from the TLTC Bylaws:**

- 3.1 There shall be four (4) classes of membership (i.e., regular, family, social and seasonal).
- (A) A regular (active) member is entitled to vote and shall be a property owner of record who has paid, up-to-date, all assessments, dues, fees and fines due the T.T.P.O.A. A property owner can only apply for a regular membership. A regular member is entitled to guest privileges. A regular member can sign in a guest **five** (5) times and then the guest must become a family member or a social member or a seasonal member or be denied bar privileges. A regular member sponsoring a guest for the day is responsible for all actions by that person(s).
  - (B) A family member is not entitled to vote and must have a close relationship (by blood or marriage) to the sponsoring regular member. A family member is entitled to guest privileges. A family member can sign in a guest **five** (5) times and then the guest must become a family member or a social member or a seasonal member or be denied bar privileges. A family member sponsoring a guest for the day is responsible for all actions by that person(s).
  - (C) A seasonal membership shall be for no longer than 90 consecutive days. This applicant must be sponsored by a board member and the applicant be approved by a majority of the board. *Note:* The sponsoring board member cannot be held liable for any infractions by the seasonal member.
  - (D) A social or seasonal member is not entitled to vote and membership is open to persons who are not a property owner and are sponsored by a regular member. A social or seasonal member cannot sponsor a guest for membership nor can a social or seasonal member sign in a guest for the day.
- 3.2 All applicants for membership shall have reached their 21<sup>st</sup> birthday. Positive identification may be required of every applicant.
- 3.3 Applicants for membership shall make application on the forms supplied by the corporation.
- 3.4 Applications shall be signed by the applicant and a sponsor, where necessary, who shall be a member in good standing.
- 3.5 Application for membership during a rental period must be sponsored by the T.L.T.C. Board of Directors.
- 3.6 The Board of Directors shall investigate and review all applications submitted, on a regular basis, and shall vote on the question of the admittance of said applicants to membership. A majority vote of the Board of Directors in favor of admission shall admit any applicant to membership subject to these Bylaws and any amendments thereto, and the Rules and Regulations passed by the Board of Directors.
- 3.7 Any applicant denied membership shall be informed in writing.
- 3.8 Membership in the corporation shall be evidenced by the membership card which shall be numbered and shall be entered into the records of the corporation as they are issued. In addition to the registration number, the membership card shall have the name of the corporation, the name of the member and the fact that the Corporation is a not for profit corporation, which shall be noted conspicuously on the back of the card. Further, no card shall be valid unless executed by the member himself.
- 3.9 A membership in the corporation is not transferable.
